Purpose and method of use in the building:

- Ceramic shaped bricks with an absorbing power of up to 3 % in dry state, pressed and glazed (Group B1b), Catalogue Number Gxxxxxxx, which are suitable for lining of showers, bathtubs and swimming pools, in various sectors, for instance, healthcare, food and chemical industry, etc. The given group includes step tiles, skirting, corners, continuous and spillover edges, barrierless shaped bricks, borders, etc.
- Ceramic dry-pressed, glazed and unglazed shaped bricks with an absorbing power of up to 0.5 % (Group B1a), catalogue numbers Txxxxxx and Dxxxxx, which are suitable for special shape exterior and interior applications on wall and floor tiles, façades, pools, etc. The given group includes shaped bricks, balcony shaped bricks, step tiles, skirting, corners, channels, barrierless shaped bricks, borders, etc.
- Extruded and glazed ceramic shaped bricks with an absorbing power of up to 0.5 % (Group A1a), catalogue number XPxxxxx, which are suitable for use as wall and floor tiles for interior and outdoor public and private swimming pools. It concerns special swimming pool ceramics, which include the tiles of the individual walls and the pool bottom, special shaped bricks for the overflow edges and channels, system of rounded edges, etc.

Prior to installation of the product, it is necessary to respect the type of material and observe the manufacturer's instructions that are stated on the packaging, as the case may be, on the leaflet inside the carton, in the Technical Catalogue and Manufacturer's Catalogue.

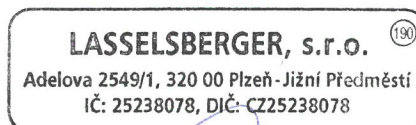
